Policies and Procedures

The Camden BPW Barn Sale_{sm} is an annual arts and crafts event, and this is our 42nd year of operation. It is held on the last Saturday in September. In 2010, the date for the Sale is September 25th. Sale hours are from 9:00 a.m. to 5:00 p.m. The Barn Sale_{sm} is a juried show that provides between 150 and 160 booths. Booth spaces will be assigned from the applications received on or before **May 31, 2010** to be considered in the initial screening. Applications are reviewed as they are received after the initial screening.

Exhibits are to consist of paintings, drawings, handicrafts, or other original works. Commercial materials are not permitted; however, the committee reserves the right to accept items it deems acceptable for the show. **Show sponsors and/or their representatives will check the exhibits during the day,** and exhibitors showing commercial materials will be required to remove them from their displays unless the items are approved by the committee as acceptable items before the show. No raffles by exhibitors are allowed.

Please be sure to enclose **two current photographs** representative of the work to be sold and a check or money order with the completed application form. **Applications returned without photographs may not be considered. This applies equally to crafters who have exhibited at the Barn Sale_{sm} before.**

A committee will review each application following the May 31, 2010, deadline. Those applicants that are approved will receive an acceptance letter. Their checks will then be deposited and their photographs retained until Sale day. Those applicants that are not approved will receive notification and their check and photographs will be returned.

Each booth measures *approximately* 12' x 12' and may be reserved for \$65 for a regular booth and \$80 for a booth with electricity. A maximum of two booths may be reserved, but a combination of one electrical booth and one regular booth is not allowed. Exhibitors are responsible for equipping their own booth. The Barn Sale_{sm} is an outdoor event, and no alternate date or site is planned. Exhibitors should, therefore, come prepared for the weather.

Set-up is allowed on Friday, September 24th; however, Camden BPW cannot provide security for the area. It is recommended that exhibitors use their own discretion about leaving crafts in the booth overnight. Exhibitors may not spend the night in the Sale area. On Saturday, exhibitors may begin setting up at 6:00 a.m. No more than two vehicles per booth will be allowed in the Sale area. Please keep in mind that all vehicles must be out of the Sale area by 8:30 a.m. and may not reenter until after 5:00 p.m. Pets are prohibited in the exhibit area during Sale hours. All exhibits must remain on display during the Sale hours of 9:00 a.m. and 5:00 p.m.

General Show Rules

1. All merchandise displayed must be handmade by the exhibitor; however, the committee reserves the right to waive the handcrafted requirement for items it deems suitable for the sale. No raffles by exhibitors are allowed.
2. Any craft person exhibiting items that are not handmade will be required to remove those items from the display unless the items are approved by the committee as acceptable items before the show.
3. Pets are prohibited in the exhibit area during Sale hours from 9:00 a.m. to 5:00 p.m.
4. Two **CURRENT** photographs with the name and address of the exhibitor on the back must be received with each application.
5. Exhibitors may display and sell only that craft category or art medium for which they were approved and **MAY NOT TRANSFER, SHARE, OR ADD** media to the exhibit space without the prior consent of the show sponsor.
6. Booth space may not be sold or transferred.
7. Exhibitors are strongly encouraged to demonstrate their craft in their assigned space.
8. All display equipment is the sole responsibility of the exhibitor.
9. Exhibitors are responsible for keeping their area clean, **including cleanup and trash removal (to the main waste removal area behind the Barn) at the conclusion of the show. Exhibitors leaving trash in the sale area at the end of the day may not be invited to next year's show. Used zip ties are considered trash and should not be left on the grounds.**
10. The booth is to be open and staffed during the entire Sale.
11. No exhibits may be set up so as to obstruct view of or access to another exhibit, or so as to impede the free flow of traffic.
12. After initial unloading, exhibitors will park their vehicles at the outer perimeter of the parking lot or other area so designated.
13. No vehicles will be allowed in the Sale area between the Sale hours of 9:00 a.m. and 5:00 p.m.
14. A maximum of two vehicles per booth is allowed in the Sale area during setup. Semi-trucks are not allowed. Two parking permits will be provided; only those vehicles with permits will be allowed to park free of charge in the exhibitor area. Packets with parking passes and other pertinent information will be available at the check-in area beginning at 6:00 a.m. on Sale Day.
15. Please be aware that some streets around the Sale area are designated one-way on Sale Day. **All** workers and volunteers **must** observe one-way street designations and **are not** allowed to travel on **any** one-way street against the traffic.
16. Overnight parking of vehicles or campers inside the Sale area is prohibited.
17. The nonrefundable fee of \$65 or \$80 per booth must accompany the application.
18. A professional standard of conduct and dress is expected at all times.
19. Two (2) nametags will be provided for each exhibit space and must be worn during Sale hours.
20. Failure to abide by any of the rules governing this show will prevent the exhibiting craft person from being accepted to next year's Sale.
21. Camden BPW contracts with independent food vendors to provide the concession service; therefore, craft persons are not allowed to sell food.
